### PFAS Remark :

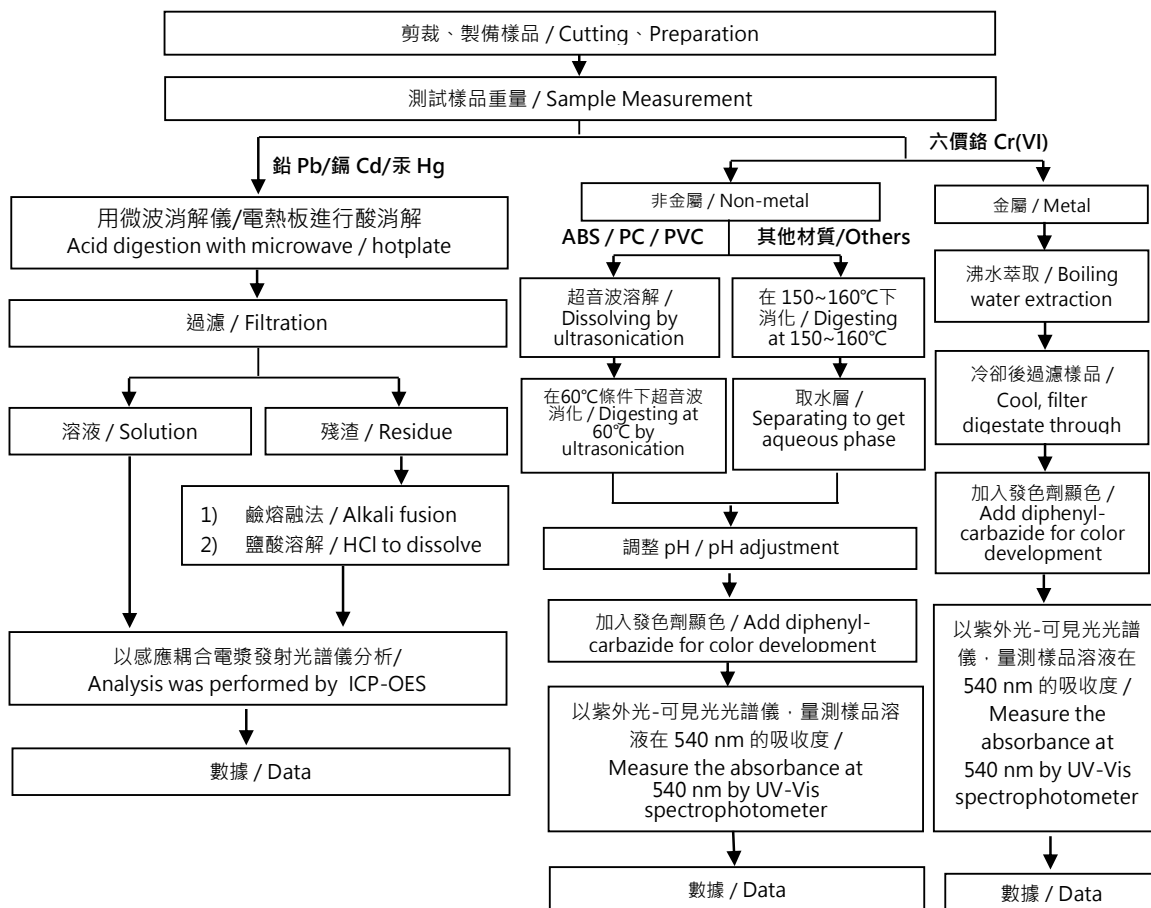

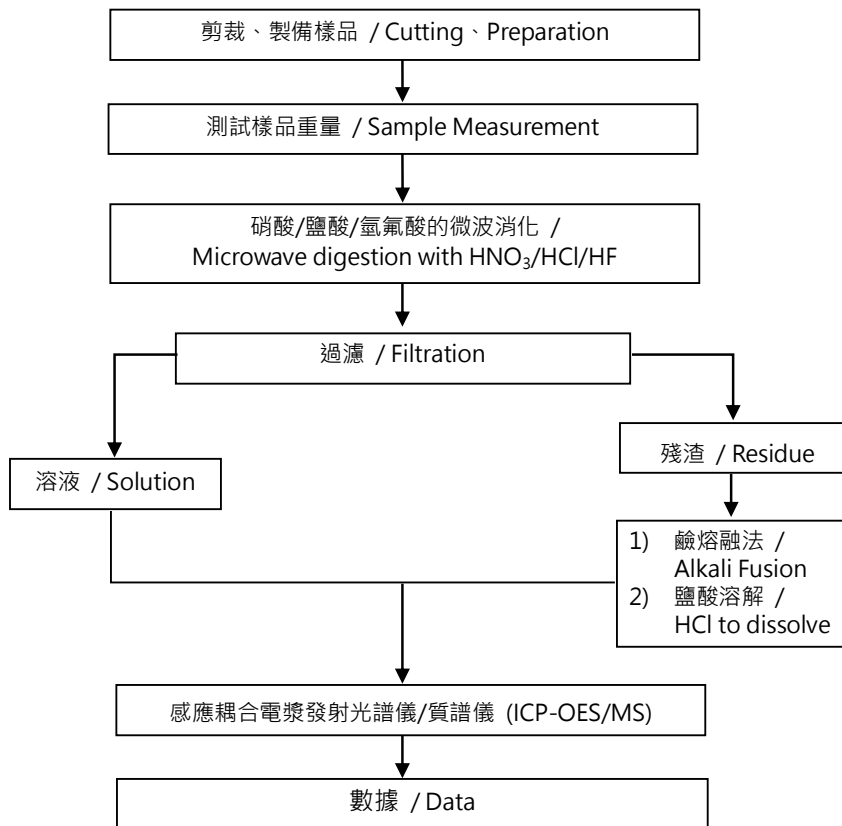

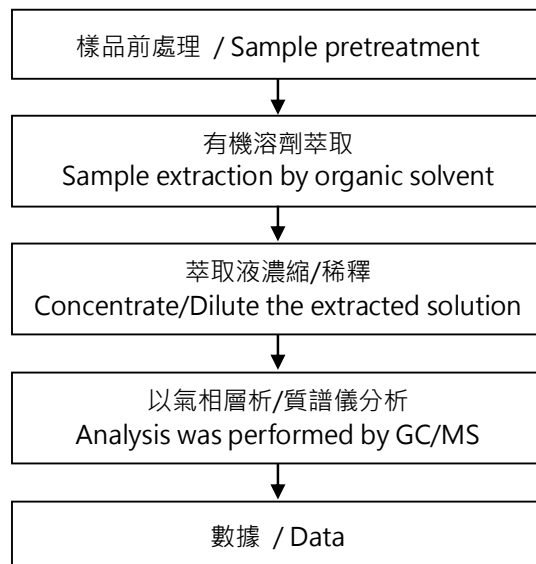

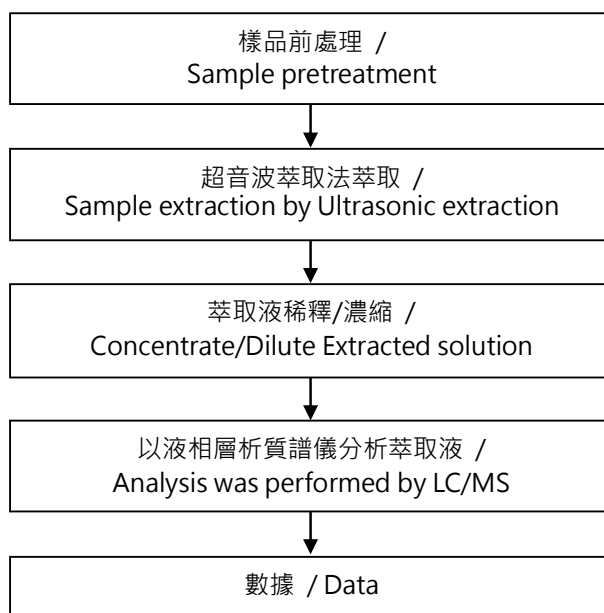
